The Division of Program Compliance at Tennessee Housing Development Agency (THDA) conducts free training for owners, managers, and dedicated compliance staff of Project-Based Section 8 properties assigned to THDA for monitoring. This training will assist personnel with compliance with HUD 4350 and the annual management and occupancy reviews conducted by THDA. Owners and their staff are encouraged to attend training sessions as often as they deem necessary to understand the requirements for compliance, although annual sessions are recommended by THDA.

**Participants must REGISTER AT LEAST TWO WEEKS IN ADVANCE by mailing or faxing the attached form to Division of Program Compliance at THDA.** Forms received after that date may not be accepted due to class size restrictions. ## **COMPLIANCE TRAINING LOCATIONS**

### **NASHVILLE:**

Parkway Towers – 12<sup>th</sup> Floor, Training Room  
404 James Robertson Parkway, Nashville, TN

Directions from I-40 WEST or EAST: Take the Charlotte Street Exit #209A. You will go north (from I-40 West turn right/from I-40 East turn left) towards the downtown area on Charlotte Avenue. The sixth stoplight will be the intersection of 5<sup>th</sup> Avenue. Make a left at the stoplight. Then take 5<sup>th</sup> Avenue to the first right which is Gay Street, where you will make a right. Go to the stoplight and proceed on Gay Street to the four-way stop. Make a right at the four-way stop unto 3<sup>rd</sup> Avenue. Parkway Towers is the large building on the right on 3<sup>rd</sup> Avenue. There is paid parking in the building garage. Take the elevators to the 12<sup>th</sup> Floor and follow the signs to the Training Room. Please allow for extra time for parking. Hotel information can be obtained from the Nashville Visitors Bureau at 615 743-3000.

### **KNOXVILLE:**

State Office Building – 7<sup>th</sup> Floor, Conference Room A  
531 Henley Street, Knoxville, TN

Directions from I-40 EAST: Take Exit #388. Follow the sign 'To Downtown'. Pass under the Knoxville viaduct (looks like a bridge). The Knoxville State Office Building sits on the right side of Clinch Avenue beside the Holiday Inn and the Sunsphere. Paid parking is available at the Holiday Inn.

Directions from I-40 WEST: Take the James White Parkway Exit. Immediately exit James White Parkway on Summit Hill Drive. At the fourth traffic light, turn left on Henley Street. At the first traffic light, turn right on Clinch Avenue. The Knoxville State Office Building sits on the right side of Clinch Avenue beside the Holiday Inn and the Sunsphere. Paid parking is available at the Holiday Inn.

### **MEMPHIS:**

Donnelly J. Hill Building – 2<sup>nd</sup> Floor, Auditorium  
170 Main Street, Memphis, TN

Directions from I-40 WEST or EAST: Take the Second Street Exit. Second Street is a one way street going south. Merge over to the right lane at Poplar and 2<sup>nd</sup> Street and the Hill Building will be on the right. Paid parking is available throughout the Main Street area. Please allow for extra time for parking.
